Original Goals of the Project

- Foster dialogue among diverse rural/urban interests
- Assess best practices, lessons learned, and alternative strategies for rural vitality
- Act as a catalyst in forming collaborations and innovative projects that enhance rural vitality

Previous Progress Made toward the Original Goals

CVC organized in 2002. A board and governance structure was established with 17-30 rural leaders representing diverse interests. Community Entrepreneurship, Community Philanthropy, and Rural-Urban Policy Studies are three initiatives adopted for focus of CVC programs. During the first five years, CVC co-sponsored entrepreneurship support projects in more than 110 communities, conducted training and assisted in forming over 85 community philanthropy entities, and completed more than two dozen rural-urban policy studies and dialogue projects.

E. Leverage of Federal funds

- CVC requires a dollar for dollar match for local projects; \$90,000 matched entrepreneurship projects; \$50,000 matched philanthropy projects; ISU provides salary, office, and indirect match of \$125,000; The \$265,000 combined total is more than a dollar for dollar local match for federal funds received.
